Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding document for e-submission from PPMO's website http://www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the non-refundable fee of NRs. 3,000/- in the Revenue (Rajaswa) account as specified below and electronic scanned copy (pdf format) of the Bank deposit voucher shall also be submitted along with the electronic bid files.

- 3. Sealed bids must be delivered to **Ministry of Youth and Sports, Singhdurbar, Kathmandu** at or before 12:00 hours of **Chaitra 13, 2073**. Bids shall be valid for a period of 90 days after the deadline of bid submission. All bids must be accompanied by a bid security of amount mentioned above deposited in Dharauti Khata No. **135001 of DTCO** (Singhdurbar Kathmandu Paying Office) in the **Office Code No. 27/343/01** or accompanied by a Bank Guarantee issued by commercial Banks *valid 30 days beyond Bid validity*. Bids received after the deadline of the submission will be rejected. Bids will be opened in the presence of the Bidders representatives who choose to attend at the address below at 13:00 Hours on **Chaitra 13, 2073**.
- 4. If the last day for purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
- 5. Bids should comply in all respects with the Instructions to Bidder included in the Bid Document. Non compliance with this instructions will result in disqualification.
