Bidders, submitting their bid electronically, should deposit the non-refundable fee of NRs. 3,000/- in the Revenue (Rajaswa) account as specified below and electronic scanned copy (pdf format) of the Bank deposit voucher shall also be submitted along with the electronic bid files.

3. Sealed bids must be delivered to **Ministry of Youth and Sports, Singhdurbar, Kathmandu** at or before 12:00 hours of **Mangsir 20, 2074**. Bids shall be valid for a period of 90 days after the deadline of bid submission. All bids must be accompanied by a bid security of amount mentioned above deposited in Dharauti Khata No. **135001 of DTCO** (Singhdurbar Kathmandu Paying Office) in the **Office Code No. 27/343/01** or accompanied by a Bank Guarantee issued by commercial Banks **valid 30 days beyond Bid validity**. Bids received after the deadline of the submission will be rejected. Bids will be opened in the presence of the Bidders representatives who choose to attend at the address below at 13:00 Hours on **Mangsir 20, 2074**.
